URGENT FIELD ACTION NOTICE

Affected Products:

ULTIMA washer/dryer series (1400LX, 1400LXP and 1600LXP)

Product Issue:

Getinge Life Science has received complaints where the screed/cylinder link of the ULTIMA washer/dryer was broken, leaving the door no longer retained when opened which may

result in an unreasonable risk of harm to the user.

Resolution:

Getinge proposes to repair the affected unit at your facility to

ensure that it is working effectively and safely.

PLEASE FORWARD THIS INFORMATION TO ALL RISK MANAGERS AND ALL USERS OF THE ULITMA WASHER/DRYER SERIES (1400LX, 1400LXP AND 1600LXP) WITHIN YOUR INSTITUTION.

Dear Risk Manager:

Getinge Life Science is initiating an Urgent Field Action Notice for the ULTIMA washer/dryer series (1400LX & 1400LXP and 1600LXP) due to the potential malfunction of the hydraulic/pneumatic braking mechanism, shown in Figure 1, which may result in an unreasonable risk of harm to the user.

Our records indicate that you may have an ULTIMA washer/dryer series (1400LX & 1400LXP and 1600LXP) with a serial number that is affected by this recall.

This letter is to inform you of the corrective action being conducted by Getinge Life Science to prevent a potential malfunction with the ULTIMA washer/dryer series (1400LX & 1400LXP and 1600LXP). This corrective action will be performed to prevent any possible hazard to staff, goods, and equipment.

The issue found may cause the ULTIMA washer/dryer door not being latched and possibly falling onto the operator/individual. This malfunction has a potential to cause serious injuries such as blunt injury to the neck, shoulder, and upper back. Also, it could result in minor injury including a hematoma/bruise, a contusion/laceration, or permanent damage to the vertebrae, nerves, or the vasculature.

Important notes:

- This failure does not occur during a washing/drying cycle.
- The door cannot fall entirely as it is horizontally blocked by a mechanical stop, leaving the loading racks unaffected.




Figure 3: Screed/Cylinder link breaking

This potential for malfunction is caused by a failure of the screed/cylinder, shown in Figure 2, due to the part being too constrained resulting in a rupture of the screed/cylinder link, as shown in Figure 3.

This Urgent Field Action Notification is to inform customers with the affected product to remove from area(s). Subsequently, an upgrade kit will be provided to replace existing door fixating mechanism with a new one. The installation will be done by Getinge service technicians at no charge to the customer. You will be contacted by a Getinge Service Tecnician when the upgrade kit is ready for installation at your facility.

Only the the ULTIMA washer/dryer series (1400LX & 1400LXP and 1600LXP) serial numbers identified on page 5 and 6 are impacted by this field action.

- 1. Please examine your inventory immediately to determine if you have any ULTIMA washer/dryer series (1400LX, 1400LXP, 1600LXP) with the product codes/serial numbers listed in this notice.
- 2. Should you have any affected product, please remove from area(s) of use until a Getinge trained and authorized service technician replaces the new door fixating mechanism.
- 3. Whether or not you have affected product(s) with the serial numbers listed in this notice, please complete and sign the attached URGENT FIELD ACTION NOTICE - RESPONSE FORM (page 4) to acknowledge that you have received this notification. A Getinge Service Technician will contact the person you list on the Customer Response Form to schedule service for an inspection.
