Public Comments: Violation #1b for missing Certified Food Safety Manager certificate has been corrected with

reasonable compliance.

Inspector: Muzna Rauf Status: Compliant Public Comments: Violation #6 for empty soap and paper towel dispensers has been corrected with reasonable

compliance. At the time of the inspection soap and paper towels were provided next to all the

handwash sinks located inside the kitchen and restrooms.

Public Comments: Violation #14 for unclean and deteriorated cutting boards has not been corrected with

reasonable compliance. Observed two deteriorated and yellow/black discolored cutting boards

on food prep surfaces inside the kitchen. REPEAT VIOLATION.

Action Plan: California Retail Food Code §114130.3& 114177. Surfaces such as cutting blocks and boards that are subject to scratching and scoring shall be resurfaced if they can no longer be effectively cleaned and sanitized, or discarded if they are not capable of being resurfaced.

Public Comments: Violation #23 for multiple rodent droppings inside facility has not been corrected with

reasonable compliance. Observed multiple old and new fresh rodent droppings on the floor inside hallway leading out the side exit, underneath shelving in the kitchen, underneath the warewashing sink in the back room with the walk-in cooler, and on the roof of the walk-in

cooler. REPEAT VIOLATION.

Action Plan: Ensure facility is free of all evidence of rodent infestation. Operator instructed to have all floors and equipment properly cleaned and to have all rodent droppings removed from

the facility.

Recommendation: Hire professional Pest Control Services to help with the current rodent

infestation.

Public Comments: Violation #35 for unapproved use of equipment has been corrected with reasonable

compliance. Non-working refrigeration unit is currently not being used as a storage unit,

especially to hold dry food products.

Inspector: Muzna Rauf Status: Compliant

Public Comments: Violation #44 for clutter of personal items and vermin proofing has been corrected with

reasonable compliance. All personal items stored in the upstairs rooms, including shoes,

clothing, luggage etc. have been removed.

Inspector: Muzna Rauf Status: Compliant Public Comments: Violation #45 for floors, walls and ceiling not properly built, maintained or clean has not been

corrected with reasonable compliance.

1) Broken roof skylight - repairs still pending. Building management to contact facilities to have it repaired.

2) Multiple old and new rodent droppings on the floor, underneath shelving, underneath warewash sink in back room, and on the roof of the walk-in cooler.

3) New Finding - Multiple 1/4" holes in the wall next to shelving opposite the walk-in cooler.
